# Howard Young Medical Center

- Replaced Lakeland Memorial Hospital (built with community funds in 1954).
- Opened in 1977.
- Sold to Ministry Health Care 2001.
- Acquired by Ascension in 2016.
- Serves Oneida, Vilas and Iron Counties.



## Howard Young 1878-1972

- Wealthy art dealer, regular visitor and lover of the Northwoods, where he owned a home and spent many summers.
- Left the bulk of his estate (\$20 million) to the hospital, with \$7 million designated towards building a new hospital.
- Only caveat: name change.
- Remainder placed in an endowment trust fund, the annual income from which could be used by the hospital for general purposes.
- Today trust holds roughly \$50 million, \$2 million per year to help fund the nonprofit hospital.





12 private patient rooms.

# The Opiate Crisis Hits Home

#### MINOCQUA -

Two people in Minocqua said they wanted a Marshfield Clinic nurse practitioner to see what pain felt like. According to police they locked the practitioner in an office Tuesday and threatened her with a hatchet and meat tenderizer, according to police. Police also found loaded revolver in their bag. Jillian and Joseph Buza could face nearly three decades in prison combined.

During an appointment with her nurse practitioner at Marshfield Clinic in Minocqua, 39-year-old Jillian Buza looked over to her ex-husband and said, "Are you ready?"

That's when 70- year- old Joesph Buza cornered the practitioner with his wheelchair and held a hatchet and meat tenderizer to her face while Jillian duct taped the door shut, according to the criminal complaint. Police believe the pair went to Marshfield Clinic Tuesday with the intention of crushing Jillian's nurse practitioner's feet and hands.

Joesph told police she was "making their lives a living hell."

The pair was upset with the practitioner for trying to wean Jillian off opioids.

In a phone interview, Minocqua Police Chief Dave Jaeger called the staff at Marshfield Clinic the "real heroes."
